The proposed changes to the event format included the following: <ul style="list-style-type: none"><li>• Holding the majority of the event in the parking lot area of Markham Civic Centre;</li><li>• Having more of a street festival feel to the event;</li></ul> |             |

|             | <ul style="list-style-type: none"><li>• Discontinuing the use of inflatables at the event due to the liability to the City.</li></ul> <p>The Committee will look at new ideas for children's activities that will still provide patrons with good value for their money when purchasing an all day play pass.</p> <p><b>B. Staging and Entertainment</b></p> <p>With the new proposed event format there will be less elaborate entertainment and more community based entertainment. The local community and schools can be engaged to perform at the event. This could be done through holding auditions for performers. The new proposed entertainment format would also help reduce the cost of the staging.</p> <p>Other suggestions for entertainment included the following:</p> <ul style="list-style-type: none"><li>• Having various sports activities (e.g. badminton and table tennis);</li><li>• Having video game stations;</li><li>• Having the children create murals in celebration of the PAN AM Games.</li></ul> <p>Members were encouraged to submit additional entertainment ideas via email.</p> <p><b>C. Finance</b></p> <p>It was reported that Judy Rigby will be the 2013 Finance Representative on the RBC Markham-Children's Festival Committee.</p> <p>It was advised that additional clauses are being added to this year's contracts with both the vendors and sponsors to protect the City from financial liability.</p> <p>The City is also looking at the possibility of having a rain date for the event and at what the</p> |             |

Sponsorship</b></p> <p>It was reported that \$16,500 was raised through sponsorship in 2012 for the Children's festival. Sponsorship ranged from about \$1,000 - \$7,500.</p> <p>It was recommended that this Committee create a small booklet or possibly a colouring book for the event where businesses can be advertised. Revenue could then be generated through the sale of the advertisement space.</p> <p><b>E. Operations</b></p> <p>The Committee recommended that a representative from Operations attend future meetings.</p> <p><b>F. Volunteers</b></p> <p>Staff thought that the number of volunteers could possibly be reduced with the new proposed event format and stressed the importance of keeping the volunteers busy at all times.</p> <p><b>G. Corporate Communications/Advertising</b></p> <p>Dennis Flaherty, Director of Communications, provided the following update on the Corporate Communications/Advertising of the event:</p> <ul style="list-style-type: none"><li>• Looking at refreshing the look of the promotional materials for the Children's Festival;</li><li>• Planning on using social media, the website, the City's new mobile app and the City page to promote the event;</li><li>• Hiring a part time event coordinator who will assist with the event;</li></ul> | Invite a representative from Operations to attend meetings – Andrea Conlon/Laura Gold |
