## 2. UPDATE ON RETAIL SUPPLY

Claudia Marsales, Senior Manager, Waste and Environmental Management advised the Subcommittee that notices were sent out to all the retailers in Markham regarding the clear bag garbage program. She also advised that Dave Douglas, President VisionQuest Environmental Strategic Corporation has been hired to personally meet with the retailers/buyers and ensure that the clear bags will be available in Markham stores for purchase by the program launch date of April 30, 2013.

## 3. AMNESTY PROGRAM

Staff advised that they have been placing clear bag tips in the newspaper and on the web site reminding residents that diapers, private papers etc are acceptable in the green bin.

There was considerable discussion regarding the number of privacy/shopping bags that should be permitted in the clear bag. The Subcommittee suggested that the advertising relative to the clear bag garbage program must include information regarding the privacy/shopping bag(s).

Staff advised that the clear bag program begins April 30, 2013 and pointed out that if residents have their garbage in dark bags they will be picked up the first and second week of the program. OPPS stickers will be left to remind residents to use clear bags. On the 3<sup>rd</sup> collection cycle, bags will be left behind with a sticker.

Staff presented the Subcommittee with pictures of the three stickers that will be used to transition to clear bags. Staff also presented a picture of a 'gold star' sticker that will be placed on the green bin or blue box for those residents who have properly sorted all their recycling and waste items.

The Subcommittee suggested the following:

- Amend the wording on the stickers to read "clear garbage bags now required for garbage"
- Test the adhesive on the stickers prior to placing on the resident's bins
- Amend the wording on the gold sticker "Thank you for doing your part in the Markham Clear Garbage Bag Program" and include "You are a Star"

#### 4. MARKHAM ENVIRONMENTAL ISSUES COMMITTEE (MEAC) PROGRAM SUPPORT

Staff advised that they need to attend the next MEAC meeting to outline what is involved with the Ambassador program. It was noted that the next MEAC meeting is <u>Thursday March 21</u>, 2013 at 7:00 p.m. in the Ontario Room.
