Based on the description of proposed work as set out in Schedule "A", the Contractor will arrange for all necessary utility clearances including hydro, gas, water and sewage, telephone and cable, and provide clearance receipts to the Supervisor of Forestry (or designate) prior to the commencement of work.

The Contractor shall be qualified to perform all work and shall carry out all work in a good and professional workmanlike manner in accordance with the City's latest standards and requirements and all other legislative requirements including without limitation, the Electrical Utility Safety Association Rules from The Infrastructure Health and Safety Association, the Ontario Occupational Health and Safety Act, the Ontario Ministry of Transportation Highway Traffic Act, the Workers Compensation Act.

The Contractor shall obtain all necessary permits and licenses and pay all required fees and shall also provide all notices as required by law or policy prior to commencement of the work. In default of payment, the City may recover the costs incurred in a like manner as municipal taxes.

The Owner hereby waives any claim whatsoever that the Owner may have against the City of Markham that may arise as a result of the permission being granted for the work herein described to be undertaken on the street tree adjacent to the Owner's property and the Owner hereby agrees to indemnify and save harmless the City of Markham against all actions suits, claims and demands whatsoever which may be brought against or made upon the City and from and against all loss, costs, damages, charges and expenses whatsoever which may be incurred, sustained or paid by the City for or by reason of or on account of the permission hereby granted.
