 - Removed reference to QMS Controller and replaced with QMS Coordinator.
 - Where necessary, QMS Coordinator was revised to QMS Representative (changes would not be required if the position title is revised).
- Revised the QMS Policy for easier recognition by staff, Council, and the public.
- Removed business related activities and placed the activity in the appropriated System Level Document (SLD).
 - Moved documentation regarding the Waterworks Training Model to the SLD.
 - Moved reference to Standard Operating Procedures to SLDs.
