1. MINUTES OF THE JULY 24, 2012 SOUTHEAST COMMUNITY CENTRE & LIBRARY DESIGN SUBCOMMITTEE

2. REVIEW AND ENDORSEMENT OF SCHEMATIC DESIGN BLOCKING LAYOUT FOR FURTHER SCHEMATIC DESIGN DEVELOPMENT BY PERKINS + WILL

Duff Balmer, Perkins + Will delivered a PowerPoint presentation providing a revised Program Blocking Option 1 (from the July 24th meeting) for the Southeast Community Centre & Library.

The Committee was pleased with the revised Program Blocking Option 1 and suggested that the following also be considered:

- Ability to open the gymnasium to the adjacent outdoor area to the East
- Move the proposed connecting bridge on the inside of the building to the West
- Include seating in front of the gymnasium area along the south side of the gym
- Consider moving the main entrance (on the south side of the building) over to the to align with the administration desk on the North side of the atrium
- Consider including a view to the East of the building from the Older Adult area
- Add the children's indoor play area at only one storey high and 1500 sf
- Ensure the library floor plate remains as large as possible on the first floor and provide a higher second floor ceiling height
- Have the library overlook the atrium area and lookout to the dropoff circle landscape
- Move the café closer towards the NE corner of the library
- Include a lot of glass on the eastern wall of the building to allow people from the inside the ability to view any activities going on in the outdoor space
- Move the corridor on the 2nd floor to the Youth area from the South side of the room to the North side.

3. VISIONING SESSION: DISCUSSION ON ARCHITECTURAL CHARACTER, QUALITY, FEATURES & MULTI-CULTURAL CONSIDERATIONS

Duff Balmer, Perkins + Will delivered a PowerPoint presentation providing some examples of different architectural designs and materials to consider for the Southeast Community Centre & Library.

The Committee suggested that following relative to the building design:

- Exterior building overhangs/screens to manage sunlight
- Do not want the building to look like it is composed of blocks
- The four sides of the building do not necessary have to be in unified in look (eg. Mixture of glass, brick, wood or other appropriate material)
- Evaluate how the North exterior wall can vary in setback along its length
- Ensure the design fits in with the demographics and built form of the area
- Incorporate as many sustainable initiatives as possible
- Incorporate a timeless/dateless look
