2. SITE AND PROGRAM

Duff Balmer, Perkins + Will delivered a PowerPoint presentation outlining the site, site layout and programs for the Southeast Community Centre and Library.

The Committee discussed the size of the proposed room for children with special needs. Staff advised that they will do more research to determine the needs of the community.

There was brief discussion regarding whether the cardio theatre balcony north of the stage should have multiple levels.

3. PUBLIC MEETING SUMMARY

Phil Fenech, Perkins + Will provided the Committee with a synopsis with respect to the Community Public Information Meeting held on September 10, 2012.

It was noted that there were no direct requests for additional program area, no major concerns and no requests for deviation from the community.

Mary explained that there were some concerns raised about the relocation of the site, however, after explanation of the necessary confidential process of land purchase and improved transit access to the 14th/Middlefield site, the community was generally satisfied.

4. SCHEMATIC DESIGN PRESENTATION

Duff Balmer, Perkins + Will delivered a PowerPoint presentation outlining the proposed schematic design for the Southeast Community Centre & Library. He also described the proposed materials.

The Committee provided the following comments relative to the proposed schematic design for the Southeast Community Centre & Library:

- Too boxy
- Not pleased with continuation of the roof to clad the North elevation
- Supportive of the Southwest view
- Generally supportive of the interior
- Like the idea of the "floating" roof try to incorporate on the northwest view
- Ensure the open wood roof does not require a lot of maintenance in future
- West facade try to incorporate more of a human scale
- Incorporate more colours into the exterior of the building
- Ensure the building is "inviting" from all sides
