1. Welcome and introductions - Eddie Mariani, Co-Chair, welcomed everyone and introduced the

Current Board of Directors - Rob Kadlovski, Eddie Mariani and Tony Lamanna, guests and

representatives from the Town of Markham.

2. Presentation by the Town of Markham - Stephen Huycke from the Town's Legislative Services

Department reviewed the established election procedures. He noted that all UBIA members in attendance (and eligible to vote) received a numbered voting card when they registered. He

informed the Members that Kimberley Kitteringham, Town Clerk, had appointed Andrew Brouwer

and himself as Returning Officers for the election.

- 4. **Constable Sal Musso** Following the recess, Constable Sal Musso spoke about security on the street and advised that the York Regional Police may be adding additional Officers to the area. - 5. Voting Stephen Huycke and Andrew Brouwer, Returning Officers, conducted the Board election in accordance with the voting procedures. Each Nominee was called alphabetically by last name. Members in attendance were asked to vote on each Nominee by showing the numbered voting cards. The votes cast for each Nominee was recorded by the Returning Officers on an excel spreadsheet.
