<p>6. NEW BUSINESS</p>	<p>a. Status of OSPCA Contract</p> <p>The Town is currently negotiating its contract with the OSPCA. It is considering both the separation of its wildlife services and the length of its contract with the OSPCA, but no decisions have been made. It was reported that there will not be a tender for wildlife services until Council determines its direction.</p> <p>It was requested that the Committee be provided with a copy of the Town's current contract with the OSPCA for it to review.</p> <p>b. 	<p>It was reported that the OSPCA adoptions are dramatically reduced, as people are not surrendering their animals as a result to the recent ringworm crisis. It was suggested that all of the OSPCA animals be placed on Markham’s website (e.g. animals from Barrie and other municipalities in Ontario).</p> <p>It was noted that euthanasia occurs at all shelters due to lack of space. Markham should consider the amount of holding space provided by the OSPCA and look into establishing partnerships with organizations like Pet Smarts and Pet Value to obtain additional short-term holding space to resolve concerns regarding the OSPCA’s euthanasia rate. It was noted that Pet Smarts and Pet Value also provide space to rescue groups. It was confirmed that the OSPCA has just over 110 spaces for cats and dogs.</p> <p>c. Phyllis the Beagle Cross</p> <p>A story was told about a lost blind dog named Phyllis the Beagle Cross. The dog was brought to the OSPCA animal shelter. When the owner asked if the dog was at the OSPCA they were wrongly informed that the dog was not there. The police recognized the dog and it was returned to its owners. It was noted that these types of issues should be brought to the Town’s attention. Mr. Bill Wiles will contact the individual to identify the gap in service so that the issue can be addressed.</p> <p>It was requested that the new Executive Director of the OSPCA be invited to a meeting and that a tour of the animal shelter be scheduled for the new Committee in the new year.</p> <p>d. Bill Bruce’s Lecture</p> <p>It was requested that the Committee preview Bill Bruce’s presentation at a future meeting or at an informal meeting. Highlights from Bill Bruce’s presentation were provided.
