#### 3. DIRECTOR'S REPORT

Ms. Francine Périnet, Director, Varley Art Gallery, provided her Director's report. The report included a staff update and a review of the programs at the Varley. It was noted that the programs taking shape at

The Chair reported that the Nominating Committee will be recommending three (3) strong applicants for appointment and that there are an additional three (3) interviews still to be conducted.

## 7. SUB-COMMITTEE REPORTS

## a) Building and Long range Planning Committee

Ms. Périnet reported that there was a minor set-back regarding the gallery floor. This issue was being resolved. No further update was provided.

#### b) Art Acquisition

Ms. Périnet advised that once the Board is at full compliment the membership of the Art Acquisition Committee will need to be reviewed and a Chair will need to be appointed.

#### c) Homes for the Holiday

Ms. Karen Chadwick reported that the Homes for The Holiday Committee is working towards obtaining additional sponsors for the 2011 event. There are currently eight (8) homes participating in this year's event. The next steps include the more refined details, such as creating the program and working with homeowners. An event is being held on September 27, 2011 to introduce the home owners and sponsors. Wine and cheese will be served.

## d) Art Auction

Mr. Paul Keeling advised that the Committee was focusing on having fewer art pieces of higher quality at the 2012 Art Auction. He also advised that acquiring the art will be challenging. It was noted that Mr. Patrick Carr, Past Board Member, has agreed to assist with the 2012 art auction.

It was reported that the Gallery is being promoted by having it open to the public and free of charge for a one month period. This was made possible by a \$5,000 donation from IBM.

## e) Development Officer Report

Ms. Francesca Dauphinais, Development Officer, provided a review of her roles and responsibilities from June to September 2011 and a work plan for October 2011. The report outlined her duties and responsibilities pertaining to the management of volunteer; the management of the website; and other duties related to the Homes for the Holiday Event and ArtsVest. The report was circulated to the Board.

## f) Art Battle at the Varley

The Chair reported that the Art Battle has been transformed into the Sphere Social Club. A launch party is being held on Saturday, January 14, 2011. Members will be invited to workshops/presentations on topics of interest for persons interested in the arts (e.g. how to build an art collection). There will also be monthly events for members (e.g. wine and cheese). The membership is anticipated to grow slowly and it is hoped that the club will increase the Gallery's membership overtime.

## 9. SPECIAL MEMBERS MEETING

The Board approved the proposed date for the Special Members meeting. It was requested that a Board meeting be held soon after the October 31, 2011 Special Members Meeting to elect the Officers. There was a discussion regarding the possibility of amending the Foundation's by-law in the future.
