Temporary road closure of Denison Street between Clayton

Dr and Gorvette Dr/Milliken Meadows Dr

RECOMMENDATION:

THAT the report titled 'Temporary road closure of Denison Street between Clayton Dr and Gorvette Dr/Milliken Meadows Dr' be received;

AND THAT the closure be in effect from 6:00 pm Friday December 2, 2011 to 12:00 pm on Sunday December 4, 2011;

AND THAT a traffic control plan and a detour route signage plan be prepared by GO Transit (Metrolinx) and submitted to the Town for approval prior to the closure of the road;

AND THAT a notice of road closure be prepared by Metrolinx and circulated to all emergency services, school boards and the residents and business located on the streets listed in Appendix A;

AND THAT the notice of road closure be placed in the local newspaper for 2 consecutive weeks prior to the date of the proposed road closure;

AND THAT advance notification signage stating start and completion dates be erected on site two weeks prior to the closure of the road;

AND THAT an exemption to the Town's Noise Control By-Law 218-89 be made to extend the hours of work for new railway track installation crossing Denison Street from 6:00 pm Friday December 2, 2011 to 12:00 pm on Sunday December 4, 2011;

AND THAT Staff be authorized and directed to do all things necessary to give effect to this resolution.

PURPOSE:

Obtain council approval for the temporary road closure on Denison Street to facilitate GO Transit (Metrolinx) construction of additional siding track.

BACKGROUND:

Metrolinx is increasing their rail capacity by adding a new siding track to the single existing track currently crossing Denison Street. A road closure must be implemented to accommodate full depth excavation of the existing road and the installation of the new track. The project has been schedule to correspond with a time of low traffic usage on Denison Street.

FINANCIAL TEMPLATE

There are no financial impacts to the Town with respect to the recommended temporary road closure.
