Renfrew Drive and Hooper Road Proposed All-way Stop

### **RECOMMENDATION:**

1) That the report entitled "Renfrew Drive and Hooper Road Proposed All-way Stop Control", be received;

- 2) And that Schedule 12 of Traffic By-law 106-71 be amended to include the intersection of Renfrew Drive and Hooper Road;
- 3) And that a letter of credit funded from the applicant in the amount of \$1,800, be deposited into Operations account #083-5399-8402-005 for the purpose of installing the necessary signs and pavement markings;
- 4) And that the Operations Department be directed to maintain the signs at the subject locations;
- 5) And that York Region Police be requested to enforce the all-way stop control upon installation of these signs and passing of the By-law;
- 6) And that staff be authorized and directed to do all things necessary to give effect to this resolution.

### **PURPOSE:**

This report recommends implementing an all-way stop control (AWSC) at the intersection of Renfrew Drive and Hooper Road to improve traffic safety and efficiency at the intersection.

# **BACKGROUND:**

In August 2010, the Ontario Municipal Board (OMB) approved the re-zoning application for the People's Christian Academy (PCA) at 245 Renfrew Drive. A traffic study was submitted with the application, identifying a need for an AWSC at the intersection of Renfrew Drive and Hooper Road. The application was approved with a \$1,800 letter of credit secured for this purpose. The school was subsequently open in September 2011.

Both Renfrew Drive and Hooper Road are industrial collector roads with a posted speed limit of 50 km/h and are located in the Allstate Business Park just west of Woodbine Avenue (see Attachment "A").

#### **DISCUSSION:**

An AWSC may be considered where provincial warrant guidelines are met, as outlined in Ontario Traffic Manual, Book 5. The warrants consider the total vehicular volume and the volume distribution at the intersection during the busiest one-hour period of the day. Operations Department conducted an AWSC analysis on a weekday between 8:00am – 9:00am, which is the busiest hour of the day. The warrant analysis results are as follows:

An AWSC is warranted when both Warrants 1 and 2 are satisfied. As shown above, the intersection <u>does meet</u> Provincial guidelines. Therefore, the Operations Department recommends that an AWSC be provided at the subject location.

Once implemented, it is expected that the AWSC will improve traffic safety at the intersection by removing the right-of-way from Renfrew Drive.

### FINANCIAL CONSIDERATIONS:

The cost of labour and materials to implement the signs and pavement markings will be paid for through the applicant's letter of credit in the amount of \$1,800. On-going maintenance costs for this installation will be included in future Operations Department operating budgets.

## **ALIGNMENT WITH STRATEGIC PRIORITIES:**

This report aligns with the community safety component of transportation/transit strategic priority.


