

## By-law 2018-73

A By-law to change a certain street name in the City of Markham

Whereas the Council of The Corporation of the City of Markham wishes to change the name of a portion of a public highway;

And Whereas the Council of The Corporation of the City of Markham at its meeting held on November 10, 2015, approved changing the street name for a portion of Woodbine Avenue to Victoria Square Boulevard;

Now therefore the Council of The Corporation of the City of Markham hereby enacts as follows:

- 1. That the portion of Woodbine Avenue, City of Markham, Regional Municipality of York legally described as: Firstly: Part Lot 21, Concessions 3 and 4, Part Lot 22 Concessions 3 and 4; and part of the road allowance between Concession 3 and 4, designated as Parts 3 and 4 on Plan 65R36221; Secondly: Part Lot 22, Concessions 3 and 4, Part Lot 23, Concession 3 and 4; and part of the road allowance between Concession 3 and 4, designated as Part 1 on Plan 65R36223; Thirdly: Part Lot 23, Concession 3 and 4, Part Lot 24, Concessions 3 and 4, and part of the road allowance between Concession 3 and 4, designated as Part 1 on Plan 65R36222; and Fourthly: Part Lot 24, Concession 3, Part Lot 25, Concession 3 and 4, and part of the road allowance between Concession 3 and 4, and Part Lot 1, Plan 184, designated as Part 1 on Plan 65R36218, be renamed to Victoria Square Boulevard.
- 2. That the portion of Woodbine Avenue, City of Markham, Regional Municipality of York legally described as Firstly: Part Lot 26, Concession, 3, part of the road allowance between Concession 3 and 4 and Part 10' Widenings, Plan 4123, designated as Part 1 on Plan 65R36220; Secondly: Part Lots 26, 27 and 28, Concession 3, Part Lots 27 and 28, Concession 4, and part of the road allowance between Concession 3 and 4 designated as Parts 1 to 4 (Inclusive) on Plan 65R36219, Except Parts 2, 3, 4, 5, 6 and 7, Plan 64R1232; and Thirdly: Part Lot 28, Concession 4, and part road allowance between Concessions 3 and 4, designated as Parts 4, 6 and 7 on Plan 65R36228, be renamed to Victoria Square Boulevard.
- 3. That the portion of Woodbine Avenue, City of Markham, Regional Municipality of York legally described as Part Lot 28, Concession 3, designated as Part 13 on Plan 65R30701, be renamed to Victoria Square Boulevard.
- 4. That the portion of Woodbine Avenue, City of Markham, Regional Municipality of York legally described as Part Lot 22, Concession 3, designated as Part 4 on Plan 65R-30128, be renamed to Victoria Square Boulevard.

- 5. That the portion of Woodbine Avenue, City of Markham, Regional Municipality of York legally described as Part Lot 21, Concession 3, designated as Part 3 on Plan 65R-30128, be renamed to Victoria Square Boulevard.
- 6. That the provisions of this by-law shall take effect at such time as a certified copy of same certified under the hand of the Clerk and the seal of the Corporation has been registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).
