

By-law 2018-75

A by-law to amend By-law No. 2002-276 being a by-law to impose fees or charges for services or activities provided or done by the City of Markham (Update Development Services fees)

Whereas paragraph 391(a) of the Municipal Act, 2001, S.O. 2001, c.25 authorizes municipalities to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it; and;

Now therefore the Council of the Corporation of the City of Markham hereby enacts as follows:
