I'll be honest; very surprised to see this added to Council agenda tonight..... I'd reviewed agenda as I usually do every Friday and did not see on that agenda..

I was aware was on DSC on Monday (yesterday) but was only able to listen in on some of the subject up to the lunch break so was unaware of the outcome of DSC as related to direction of the subject at DSC.....

I unfortunately have committed to a Family event this evening so am unable to attend tonight's council meeting.....

I do know that 2nd suites are a given based on existing "Provincial" dictates and I personally do support their existence as I have previously stated in written submissions on the subject..... I am however concerned that licensing and/or registration rates which I believe were proposed/recommended at the \$4000 level are (what I consider) excessive and I expect will effectively drive residents "underground" and we will see the continued establishing of illegal/non-registered 2nd suites in the City of Markham.....

Additionally, I am concerned that the City will only react to "complaint" situations when it comes to the policing of 2nd suites.....

Second suites is a high-visibility issue and major concern of Markham residents as are Airbnb and Rooming Houses; I would have thought that a further public meeting on the subject of 2nd suites would have been held prior to being tabled at Council.....
