



By-law 2017-56

A by-law to dedicate certain lands as
part of the highways of the City of Markham

The Corporation of the Town of Markham has changed its name to The Corporation of the City of Markham by By-law No. 2012-120 enacted and passed May 29, 2012, effective July 1, 2012, as evidenced in Instrument No. YR1847438 registered June 29, 2012.

Whereas Blocks (Reserve) 347, 348, 363, 364, 365, 367, 371, 372 and 373, Plan 65M-3888-in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

Whereas Block 176 (Reserve) Plan 65M-4014 in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

And Whereas Reserve Blocks 187, 188, 189, 190 and 191, Plan 65M-4364 in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use.

Now therefore the Council of The Corporation of the City of Markham hereby enacts as follows:


1. That Blocks 347 and 372, (Reserve), Plan 65M-3888 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Country Green Lane.
2. That Blocks 348, 363, 364 and 365 (Reserve), Plan 65M-3888 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Hikers Lane.
3. That Block 367, (Reserve), Plan 65M-3888, in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named White's Hill Avenue.
4. That Blocks 371 and 373 (Reserve), Plan 65M-3888 and Block 176, (Reserve) 65M-4014 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Albert Lewis Street.
5. That Reserve Blocks 187 and 188, Plan 65M-4364 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Bellevue Lane.

6. That Reserve Block 190, Plan 65M-4364 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Webb Street.
7. That Reserve Blocks 189 and 191, Plan 65M-4364 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane.
