

By-law 2017-9

A by-law to repeal and replace Municipal Law Enforcement Officers Appointment By-law 2015-62

Whereas section 15 of the *Police Services Act*, R.S.O. 1990, c. P.15, as amended, (the "*Police Act*") authorizes municipal councils to appoint persons to enforce the by-laws of the municipality; and,

Whereas subsection 1(3) of the *Provincial Offences Act*, R.S.O. 1990, c. P.33, as amended, provides for the designation by a Minister of the Crown of any person or class of persons as a Provincial Offences Officer for the purpose of all or any class of offences; and,

Whereas, by Orders dated July 30, 1984 and August 21, 1987, the Solicitor General has designated all employees of municipalities whose duties include the enforcement of municipal by-laws and persons appointed as Municipal Law Enforcement Officers under the *Police Act* as Provincial Offences Officers;

Now therefore the Council of The Corporation of the City of Markham hereby enacts as follows:

- 1. Employees of The Corporation of the City of Markham listed in Schedule "A" to this By-law are hereby appointed as Municipal Law Enforcement Officers and Provincial Offences Officers for the purpose of enforcing all municipal by-laws.
- 2. Employees of Security Companies who have written authorization from the City of Markham are hereby appointed Municipal Law Enforcement Officers and Provincial Offences Officers for the purpose of enforcing all by-laws providing for the parking control on private property.
- 3. Those persons who are employed by the Ontario Society for the Prevention of Cruelty to Animals to enforce the Animal Control By-law 2005-254, as amended, within the City of Markham are appointed as Municipal Law Enforcement and Provincial Offences Officers for that purpose.
- 4. By-law 2015-62, as amended, is hereby repealed.
- 5. This by-law comes into force and takes effect on it passing.

Read a first, second, and third time and passed on March 21, 2017.
