



By-law 2016-64

A by-law to dedicate certain lands as
part of the highways of the City of Markham

The Corporation of the Town of Markham has changed its name to The Corporation of the City of Markham by By-law No. 2012-120 enacted and passed May 29, 2012, effective July 1, 2012, as evidenced in Instrument No. YR1847438 registered June 29, 2012.

Whereas Parts of Lots 16, 17 and 18, Concession 9, designated as Blocks 369, 370, 371, 372, 373, 374, 375, 376 and 377 Plan 65M-3759 in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

And Whereas Parts of Lots 16 and 17, Concession 9, designated as Blocks 70, 71, 72, 73, 74, 75, 76 and 77, Plan 65M-4362 in the City of Markham, Regional Municipality of York was conveyed to The Corporation of the City of Markham for public use;

Now therefore the Council of The Corporation of the City of Markham hereby enacts as follows:


1. That Part of Lot 17, Concession 9, designated as Blocks 70, 71, 72 and 73, Plan 65M-4362 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane.
2. That Part of Lots 16 and 17, Concession 9, designated as Blocks 74, 75 and 76, Plan 65M-4362 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Gordon Landon Drive.
3. That Part of Lot 17, Concession 9, designated as Block 77, Plan 65M-4362 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Saddlebrook Drive.
4. That Part of Lot 16, Concession 9, designated as Blocks 369 and 370, Plan 65M-3759 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Berryman Lane.
5. That Part of Lot 16, Concession 9, designated as Block 372, Plan 65M-3759 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Southampton Avenue.
6. That Part of Lot 16, Concession 9, designated as Block 374, Plan 65M-3759 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Tilbury Gate.

7. That Part of Lot 16 and 17 and , Concession 9, designated as Blocks 371, 373, 375, and 377, Plan 65M-3759 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane.
8. That Part of Lot 16, Concession 9, designated as Block 376, Plan 65M-3759 in the City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Northvale Road.
