As a home owner in Sherwood-AmberGlen we are very concerned and upset that the Truck Ban on the 9th line has been removed completely, when in fact what we were told was once the hospital construction was completed that the region would consider **EXTENDING** the ban to south of Highway 7.

How can something like this happen, especially when it was our understanding that the Don Cousens Parkway was built to be in fact the Markham by-pass. The 9th line has a lot of traffic congestion now and this will only make the situation worse. Hello to all;

It has come to my attention that York Region will be presenting a report opposing any further truck ban on Ninth Line south of Hwy 7 AND lifting the existing ban north of 7 to 16th avenue.

During my time as President of SARA we were lead to believe that the existing truck ban on Ninth Line would be extended from Hwy 7 to Highway 407 once the construction of the MSH extension, the Fire Hall and the Community Centre was finished and the interchange at Donald Cousens and Hwy 407 was completed. We met with all concerned parties and,as responsible residents, agreed not to pursue this issue until all these projects were completed.Imagine if you will, how we felt when we went to request the ban we believed was owed to us only to find that not only was the Region backtracking on the ban south of Hwy 7 but had suddenly decided that the ban north of Hwy 7 was "only temporary" and was to be removed. All along we had believed that the primary reason for spending millions of dollars to build the Donald Cousens Parkway **was to divert truck traffic around residential neighbourhoods**, specifically those homes along Ninth Line.

I would like to direct your attention to page six of York Region's presentation for DSC tomorrow.

If I was on Council I think my first question would be to ask them to breakdown the types of trucks in the report; are they delivery vehicles, construction vehicles, etc. Where are they travelling to? Is it to local area or beyond? I'd ask this since construction vehicle traffic will decrease as the City is built out. If they are travelling beyond the local area then that is exactly what the DCP and the planned extension to Hwy 48 is designed for!

If the sole purpose of the DCP was to divert truck traffic the Region is doing a lousy job! 160 trucks versus 800 for Ninth Line south of Hwy 7 and 500 north of Hwy 7.

I firmly believe that this staff report is without serious merit and I think it's time for residents and our Council to stand up to staff on this issue.
