

Ambitious Target Requires Commitment From Partners And All Travellers

- 94% of all collisions are a result of driver error in actions and decisions
- Collisions are increasing and about one in four are severe; more needs to be done
- Plan identifies emphasis areas and recommends countermeasures to help reduce risk



Reduce right angle collisions by more than 30%



Pedestrian and Cycling Measures Reduce turning






Collisions in York Region (2015 to 2023)






Collisions Have Decreased By 55% Since Completion Of Bus Rapidway

Successful Plan Requires Resources, Evaluation And Monitoring

- Progress and results reported to Council
 Annually
- Estimated annual budget approximately \$12M
 - 90% integrated in existing capital budgets
 - 10% funded by automated enforcement and red-light camera revenues to manage operating budget pressures
- No additional budget required in 2024
- Future budget may be considered as part of the annual budget process



2024 Safety Projects in the City of Markham

Intersection Improvements

- Enterprise Boulevard and Rouge Valley Drive (new crosswalk)
- Highway 7 and Kennedy Road (east/west fully protected left turn and north/south crosswalk pedestrian head start)
- Highway 7 and Silver Linden Drive (eastbound fully protected left turn)
- Woodbine Avenue and Esna Park Drive/John Street (AODA)

Pavement Marking and Signage Improvements

- 14th Avenue and 11th Concession (oversized stop signs, stop bar relocation, edge line pavement markings)
- Highway 7, from Bayview Avenue to Silver Linden Drive (lane transition pavement markings and signs)
- Leslie Street, from Steeles Avenue to Highway 7 (edge line pavement markings, slow down school zone pavement markings)
- McCowan Road and Southdale Drive (intersection hatch markings)



2024 Automated Speed Enforcement in City of Markham

Mobile Automated Speed Enforcement

April to June: Highway 7 at St. Patrick Catholic Elementary School

Fixed Automated Speed Enforcement


- 14th Avenue at Trillium School
- Bayview Avenue at Thornlea Secondary School
- Leslie Street at St. Robert Catholic High School
- McCowan Road at Markville Secondary School

Red Light Cameras

- 14th Avenue and Box Grove Collector Road New
- 16th Avenue and Bur Oak Avenue New
- Donald Cousens Parkway and Ninth Line New
- Highway 7 and Donald Cousens Parkway New
- Kennedy Road and Castlemore Avenue/The Fairways New
- Leslie Street and Commerce Valley Drive New
- **7 existing Red Light Camera intersections**: 14th Avenue and Birchmount Road; 16th Avenue and Woodbine Avenue; Highway 7 and Red Maple Road; Highway 7 and Yonge Street Ramp; Warden Avenue and 14th Avenue/Alden Road; Warden Avenue and Carlton Road/Baycliffe Road; Woodbine Avenue and Steelcase Road West/Steelcase Road East



York Region Vision Zero Traveller Safety Plan



- Regional Council endorsed the Plan on March 21, 2024
- Local municipalities can leverage the Plan for developing their own road safety plan
- The Plan will integrate with all local road safety plans, including City of Markham's Road Safety Plan
